## Psychotherapy Training for the Dissociative Disorders Chapel Hill, NC

### PARTICIPANT REGISTRATION PROCEDURE

1. Participants contact instructor, Dr. Gary Peterson, and receive a registration number (“CH-#”).
2. Participants complete the ISSD Registration Form at <https://atrium.issd.org/TrainingReg.htm> or <http://www.issd.org/Training/Faxable/Faxable%20DDPTP%20Registration.htm> and pay ISSD \$420. (\$350 course registration and \$70 copyright fee). The \$70 copyright fee is separate from registration. The copyright fee covers the ISSD’s \$70 financial obligation to publishers for each copy made of the course articles. Participants notify SEI that they have registered at ISSD.
3. Participants complete the SEI Registration Form at <http://www.seinstitute.com/OnlineReg.asp?WorkshopID=53> and pay SEI \$35 for course materials.
4. ISSD requires that participants send a copy of their clinical license to SEI (FAX 919-929-1174).
5. All payments are made at least two weeks prior to the start of the course.

ISSD notifies faculty about participants who have not paid. Participants who have not paid fees are not allowed to start the course.
7. Participants who withdraw from the course after payment but before the first course session receive a registration and copyright payment refund from the ISSD, minus a \$25 cancellation fee (which covers ISSD office expenses for processing the registration).  
SEI notifies ISSD about participants who withdraw.
8. Participants who withdraw from the course after the first session receive no refund of registration, copyright or course materials fees. There are no rebates or make-ups for participants who miss class sessions.

10. CEUs are available through SEI at no charge or from ISSD at a cost of \$40. If you want the CEUs through SEI, you can tell ISSD you do not want CEUs from ISSD. SEI cannot provide CEUs for psychologists. Course instructors are required to elicit written evaluation of the course and teaching before issuing certifications to their students. ISSD will use the information to improve the course next year.
